Violation Detail(s): Failure to institute and maintain safety equipment measures and temporary construction.
Note: At the time of my inspection of a 46 story building at sub cellar level performing follow up inspection to an incident where workers collapse in sub cellar level due to carbon monoxide accumulation from gasoline generators being use. Review of documents reveal that there were no safety measures in place to safeguard personnel accessing sub cellar level during operations or preparation for hazardous activities, conforming to N.Y.C fire code and providing a safety plan for unsafe condition and operation creating a hazardous condition that occur for 9 workers. REMEDY: STOP ALL WORK PROVIDE SAFETY MEASURES FOR OPERATION GOING FORWARD CALL CSE FOR REINSPECTION.

THE COMMISSIONER ORDERS THAT YOU TIMELY CORRECT THESE CONDITIONS AND FILE A CERTIFICATE OF SUCH CORRECTION See 1RCNY 102-01 and the reverse for instructions on certifying correction.
