**Violation Detail(s):** work does not conform to approved plans (CD5)

**NOTED:** At the time of inspection I observed proposed facade alteration to an existing 20 story building with works activity present. Approved drawings show footings of Outrigger W/insafe Beam system place directly on concrete slab. Field work has footings of system place on pavers/tiles resting on pedestals. This condition presents possible collapse hazard for rigging system in the event that paver/tile cracks due to construction operations that can result in serious injuries for persons at the site. This condition is a clear violation and is not in compliance with the building code.

**Remedy:** Amend CD5 to reflect pavers/tiles with pedestal height dimensions or remove and place footing directly on concrete slab.

THE COMMISSIONER ORDERS THAT YOU TIMELY CORRECT THESE CONDITIONS AND FILE A CERTIFICATE OF SUCH CORRECTION. See 1RCNY 102-01 and the reverse for instructions on certifying correction. Uncorrected violations are subject to additional violations and penalties.
