After investigation, the enforcement agency has found there is a reason to believe that Respondent (the person or entity named on this summons) has violated the following section of Title 24, Chapter 1, of the New York City Administrative Code (Air Pollution Control Code):

DESCRIPTION OF VIOLATION: Inspector Made an olfactory observation on a public street in the vicinity of Kissena Blvd. & Kalma Avenue where mobile food vendor cart located on sidewalk was operating and serving pedestrians. Found strong chicken and shrimp type odors that emitted on to the public right away coming from mobile food vendor cart mushroom exhaust unit causing an annoyance and discomfort to pedestrians and to this inspector.
