Found DOB permit # 321834226-01-OT posted on front door. No noise mitigation plan posted alongside DOB permit. Respondent failed to keep a copy of the Noise Mitigation Plan at the construction site and shall be displayed in a conspicuous manner on the exterior of the construction site and made accessible for inspection by the public and persons authorized to enforce the provisions of this code.
