DESCRIPTION OF VIOLATION: As per citizens complaint- Respondent attached an unauthorized placard "Armored truck exempt from NYC Idling regulations" to their vehicle in order to avoid 24-163 idling violations. 24-112 (b) No person shall make, reproduce or alter or cause to be made, reproduced or altered a work permit, certificate of operation or other document issued by the commissioner or required by this code if the purpose of such reproduction or alteration is to evade or violate any provision of this code or any other law.
