DESCRIPTION OF VIOLATION: As per Citizen complaint – There was an emission of an air contaminant (Dust) noted and detected into the open air, using Debris Container. Respondent allowed or permitted (Dust) to become airborne without taking precautions, in violation of sec.24-146(c) of the NYC Air Code.
