Details of Violation(s)

After investigation, the enforcement agency has found there is a reason to believe that Respondent (the person or entity named on this summons) has violated the following section of Title 24, Chapter 1, of the New York City Administrative Code (Air Pollution Control Code):

DESCRIPTION OF VIOLATION: There was no emission of an air contaminant into the open air (Paint fumes) noted or detected at or in the vicinity of the above location. Inspection revealed a commercial store front where respondent caused or permitted the operation of a spray area at the above location without first obtaining a valid certificate to operate equipment used in a process, in violation of Sec, 24-122(b)(2) of the NYC Air Code. Inspection revealed 1 spray gun, compressor and a vehicles being prepared. Owner stated he doesn't know if he has a Tax ID for the business. Store front has no name of business. No proof of business ownership was visible or posted at the time of inspection. Advised owner reason of inspection and of the NYC air codes and of summons issued.
