Details of Violation(s)

After investigation, the enforcement agency has found there is a reason to believe that Respondent (the person or entity named on this summons) has violated the following section of Title 24, Chapter 1, of the New York City Administrative Code (Air Pollution Control Code):

DESCRIPTION OF VIOLATION: As per citizen's complaint- Respondent allowed or permitted (Dust) to become airborne without taking precautions, causing construction materials to generate dust into the public right of way while transporting such materials into a garbage truck (LIC. NY PL.# 41657PF) in violation of Section, 24-146(b) of the NYC air code. Source of particulate emissions (dust) from workers dumping construction materials without any mitigation allowing dust to become air-borne, causing an annoyance and discomfort to pedestrians in the public right of way.

Infraction Code	Infraction Description
24-146(b)	Dust allowed to become airborne - 1st offense
