DESCRIPTION OF VIOLATION: Inspected premise, found site inactive at this time. Sidewalk fencing with permit board noted. DOB # B00879132-11-GC posted on permit board. Noise mitigation plan was not posted alongside DOB permits. Respondent failed to keep a copy of the Noise Mitigation Plan at the construction site, to be displayed in a conspicuous manner on the exterior of the construction site and made accessible for inspection by the public and persons authorized to enforce the provisions of this code.
