Details of Violation(s)

After investigation, the enforcement agency has found there is a reason to believe that Respondent (the person or entity named on this summons) has violated the following section of Title 24, Chapter 1, of the New York City Administrative Code (Air Pollution Control Code):

DESCRIPTION OF VIOLATION: 06-04-24 up to date, NO Mold Work Plan has been filed for this property prior to issuance of summons. Mold Remediation Work Plans must be filed with DEP no later than TWO (2) DAYS before the commencement of mold remediation work by a licensed contractor. ARM CAPITAL RESOURCES CORP, the owner, property manager and/or responsible party of 1815 EAST 17 STREET APT. 3H BROOKLYN, failed to hire a Mold Remediation Licensed contractor who could lawfully filed a mold work plan notification with DEP. HPD issued a Mold Defect Letter on 06-04-24 after finding that the 56 sq. ft. of mold violation at said property was rectified and completed [mold problem was remediated but paperwork from licensed contractor was not available] based on their FIRST inspection on 08-23-23 (when according to HPD INSPECTOR mold was present) and subsequent RE-INSPECTION of the project site on 06-03-24 (when according to HPD INSPECTOR mold was NO LONGER present) RESULTING IN issuance of DEFECT LETTER which is only issued when mold remediation is done but no paper work is filed.

§ 24-154(b)	Mold assess/abate/ remediation done by covered or unlicensed person - 1st offense

EQUIPMENT / APPARATUS IN VIOLATION: The owner, property manager and/or responsible party failed to hire a Mold Remediation Licensed contractor.
