After investigation, the enforcement agency has found there is a reason to believe that Respondent (the person or entity named on this summons) has violated the following section of Title 24, Chapter 1, of the New York City Administrative Code (Noise Pollution Control Code):

DESCRIPTION OF VIOLATION: Respondent caused or permitted the total sound from a motor vehicle with a maximum gross weight of 10,000 lbs. or less operating on a public right of way to exceed sound levels in section 386 of the VTL. Vehicle 2006 BMW M6 NY license plate# KBG6222 was observed by a noise camera on 8/25/24 at 7:47 PM. Sound levels registered at 90.3db(a), allowable is 85db(a) measured at 50ft or more from the center of the lane.
