VEHICLE 2015 WHITE PORSCHE CAYMAN NY LICENSE PLATE# CALL981 was observed by a noise camera on 4/8/2025 at 9:05 PM. Sound levels registered at 93.8 db(a), in excess of 76 db(a) measured at 50ft or more from the center of the lane.
