DESCRIPTION OF VIOLATION: Respondent caused or permitted the total sound from a motor vehicle with a maximum gross weight of 10,000 lbs. or less operating on a public right of way to exceed sound levels in section 386 of the VTL. Vehicle 2017 MCLAREN 570S NY license plate# IIN2B8 was observed by a noise camera on 11/23/2025 at 11:27 AM. Sound levels registered at 94.4 db(a), in excess of 76 db(a) measured at 50ft or more from the center of the lane.
