DESCRIPTION OF VIOLATION: Respondent caused or permitted the total sound from a motor vehicle with a maximum gross weight of 10,000 lbs. or less operating on a public right of way to exceed sound levels in section 386 of the VTL. VEHICLE 2018 MERCEDES-BENZ E-CLASS NY license plate# LFZ8477 was observed by a noise camera on 1/19/2026 at 7:21 PM. Sound levels registered at 100.3 db(a), in excess of 76 db(a) measured at 50ft or more from the center of the lane.
