After investigation, the enforcement agency has found there is a reason to believe that Respondent (the person or entity named on this summons) has violated the following section of Title 24, Chapter 1, of the New York City Administrative Code (Noise Pollution Control Code):

DESCRIPTION OF VIOLATION: Respondent caused or permitted the total sound from a motor vehicle with a maximum gross weight of 10,000 lbs. or less operating on a public right of way to exceed sound levels in section 386 of the VTL. VEHICLE 2018 MERCEDES-BENZ E-CLASS NY license plate# LFZ8477 was observed by a noise camera on 1/21/2026 at 3:25 PM. Sound levels registered at 88.2 db(a), in excess of 76 db(a) measured at 50ft or more from the center of the lane.
