Violation Detail(s): Failure to safeguard public and property.

In response to an accident where it was reported during hoisting operations debris being hoisted down from roof level by electric hoist with bucket steel cable broke and debris fell from approx 10th story height and landed on sidewalk shed at Exp#1 damaging it. Site inspection revealed that work performed was beyond the scope permitted and hoisting equipment was not provided with design drawings to show capacity and sizes (purpose). Failure to provide adequate safety measures for scope of work created unsafe condition for public and Remed: property that occurred. STOP ALL WORK ENTIRE SITE. Provide means and methods for safe future operations moving forward.

THE COMMISSIONER ORDERS THAT YOU TIMELY CORRECT THESE CONDITIONS AND FILE A CERTIFICATE OF SUCH CORRECTION. See 1 RCNY 102-01 and the reverse for instructions on certifying correction.
