UPON REQUEST OF TRI SPECIAL INSPECTOR PERFORMING VISUAL INSPECTION OF CONCRETE PLACEMENT, A PLAN WAS PROVIDED. COMPETENT PERSON PROVIDED MARODRIGO C. HIDALGO, HOWEVER UPON REQUEST OF CERTIFICATION ONLY OSHA AND SSM CARD WAS PROVIDED.
