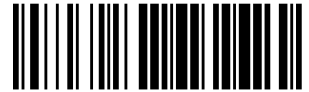

As noted at time of inspection on an active construction site. 7 story new building rebar working on 6th floor level and formwork working columns and shear walls from 5th to 6th floor. observed at exposure #2 and #4, adjacent property glass windows panels without protection floor 2 to 6 approx. 40 feet height windows without protection.

Stop all work 10 feet away from the adjoining property at exposure #2, #4.

Remedy: provide windows protection immediately provide means and method of safety measure for exterior facade glass window panel. Re-inspection: CEU@buildings.nyc.gov
