At time of inspection of a 2 story building under a vertical and horizontal extension alteration, I observed that there was no protection for the adjacent property rear yard. Two stories of new construction erected could fall and create debris dropping into the adjacent property causing damage or injury to residents while in the yard. Remedy: Comply with Code Stop all interior and exterior work at ex#3 and ex#4 and stay 10 feet back from the leading edge. Provide Over Head Protection. THE COMMISSIONER ORDERS THAT YOU TIMELY CORRECT THESE CONDITIONS AND FILE A CERTIFICATE OF SUCH CORRECTION. See 1RCNY 102-01 and the instructions on certifying correction. Uncorrected violations are subject to additional violations and penalties.
