Investigation reveal that a worker was walking down a construction ladder when he fell. Upon review of the pre shift safety meeting log worker did not sign the pre shift log and scope of work was not included. This creates a hazard for workers and property. Remedy: Ensure workers attend pre-shift safety meeting prior to start of work Stop all work entire job site only allowed to ensure each worker participate in meeting, sign the log book and enter scope of work.
