Violation Detail(s): Failure to provide protection of adjoining property during construction or demolition as required. At the time of my inspection of a 4 story new building 2nd floor level, I observed that the overhead protection for adjacent property at 555 Lafayette Avenue was not all the way to the building leaving a gap between shed and building. Failure to provide and maintain overhead protection creates a hazard for public and property.			
Remedy: Provide adequate protection for adjoining properties Stop all work at the corner of exposure #1 and 4 10 feet back from the leading edge. Request CSE for reinspection.
