At exp 2 & 3 missing bolt coverings exposing sharp edges, this creates unsafe conditions to the public possible puncture/lacerations. Stop all facade operations		
Remedy: Comply to code specifications Repair parapet panels, provide and maintain bolt coverings, Request CSE for reinspection
